2.1	Introductions/Apologies
	TS welcomed everyone to the meeting.
2.2	Minutes of the last Meeting Church Fayre – It was agreed to let the Church borrow Big Local's gazebo for the Summer Fayre. Help to put it up would be welcome. Pit Top – ABr gave an update on the pit top. RMBC are a minority shareholder of the company who owns the land. This land will be used as landfill starting in July 2018. They will consult with the local community about what happens to the land afterwards. It was suggested to invite someone from the company to one of the future meetings.
2.3	Public Art Money has been received through Section 106 for some public art in the village. ROAR attended the meeting and showed some examples of public art including architecture, sculptures, murals, carnivals etc. A steering group has been set up for this project. Consultation will take place with the village to find out what they would like to see.

SR spoke about getting charity status as this attracts much more funding, however, this is more difficult. It was suggested maybe setting up several smaller groups i.e. one for events, luncheon club, young people etc. It was agreed that if Big Local wants to continue they do need to find their own funding.
